HOW YOUR WILL CAN CHANGE LIVES

HEALTHCARE FOR THE HARDEST-TO-REACH

In rural Nepal, with limited accessible healthcare, cancer diagnoses are often made late or not at all, when the cancer is well advanced, making each case devastating. The cost of travelling for tests and often futile treatment can add up to a crippling debt for families.

Without support, girls in Nepal are more likely to miss out on education because of caring responsibilities at home.

For Maya, 12, being a carer not only means looking after her mother, but also for her wider family, rising early to clean, prepare meals and fetch water instead of going to school.

Quality healthcare not only lifts the burden from young ones like Maya, but it restores health and strength so that families can continue to support and care for one another.

Your support brings quality care at or close to home for people in rural communities and improves care in urban areas. You can help bring essential care today and protect the hopes of future generations.

BUILDING THE HEALTHCARE WORKFORCE

Bihar, one of India's poorest and most populous states, has one of the country's smallest healthcare workforces. Just 17 healthcare workers for every 10,000 people - by comparison the UK has 58 doctors alone for the same population in addition to many other health professionals.

The task of building the healthcare workforce to meet the needs of the world's poorest communities requires long-term effort. But we go further as we select vulnerable young women and help them train for good jobs. These young women gain status, income and respect, while serving their communities' healthcare needs.

In 2022, work began on building a brand new college of nursing at Duncan Hospital. Not only will it raise up a new generation of vital nurses and midwives, but also it will give girls in rural Bihar the chance to pursue healthcare careers.

This was made possible because of gifts left to EMMS International in the wills of people who were passionate about transforming lives through quality healthcare.









CRISIS-READY HEALTHCARE

Malawi bears the brunt of the climate crisis with increasingly extreme weather. Floods contaminate water supplies and storms cripple electric supplies. Healthcare services are essential in times of emergency and need to be ready to respond quickly.

Support like yours has meant we've been able to install reliable solar power at Mulanje Mission Hospital, making the hospital stronger in times of crisis and more sustainable throughout the year.

Your support means rural clinics in Malawi can have access to safe, reliable water. A special gift in your will could help install solar power to ensure hospitals keep running throughout times of crisis.

ALASTING LEGACY AT HOME HISTORIC ROOTS EMMS International traces its roots back to the Edinburgh Medical Missionary Society. It was founded in 1841 with a purpose of training and equipping dotors for Christian service overseas. Dr David Livingstone was a corresponding member and part of the rich tapestry of the society's early membership. EMMS trainees served around the world and were responsible for the development of some of the earliest healthcare systems. Many gave their lives in service of others. Even in its earliest days, that care was also expressed close to home. The Livingstone Dispensary was set up in Edinburgh's Cowgate to provide care for some of the city's poorest citizens.

CARING FOR FAMILIES

Every gift, of whatever size, has the potential to transform lives for years to come. One such gift with a remarkable impact was made in 1892, and its legacy continues today.

The Hawthorn Brae villa was left to the Edinburgh Medical Missionary Society (now EMMS International) by Margaret Sanson, with instructions that it should be used as a place of rest, recuperation and spiritual care for those who were poor, of ill-health and living in Edinburgh.

On 26 May 1894 the home was opened and applicants were examined at the EMMS Dispensary in Edinburgh's Coogate, where doctors. were to be trained for missionary service.

By October 1895 it had served the needs of 186 women and children. It served hundreds more until it was put to service by the Allied troops during both World Wars as a military hospital.

The house was later sold and the proceeds went to establish the Hawthorn Brae Trust, which continued to fund respite breaks for people in Edinburgh with chronic and life-limiting illnesses.

The legacy lives on, 130 years later, when in 2021, EMMS International entered a partnership with VOCAL to continue indefinitely the legacy of care provided by the Hawthorn Brae Trust by purchasing holiday accommodation in Scotland, equipped for short breaks for people being cared for, their families and their carers.

LEAVING A GIFT IN YOUR WILL

The make-up of your Will is a very personal decision. Here is a little information to help you as you make that decision.

Choose a gift that is right for you. The decision is yours and there are a number of different ways to include a gift to EMMS International in your will including:

- A share of your estate this allows you to easily balance your giving with what you want to leave for your family. This is a percentage of the value of your estate after any specific gifts or expenses are paid.
- A specific sum this is a set amount of money and is given before any remaining estate is shared.
- A specific item your treasured possession could give health and hope to others.

Talk to your solicitor. Your solicitor can help you through the whole process and make sure you understand any implications of your preferred giving. They can also advise on how a donation in your will can reduce Inheritance Tax. You will find our contact information and charity details on the back of this booklet should your solicitor require them.

But this is an important decision and if you would like any further information or clarification we are very happy to talk with you.
